SECTION 4: FIRST AID MEASURES

4.1 DESCRIPTION OF FIRST AID MEASURES:



Symptoms may occur after exposure, so that in case of direct exposure to the product, when in doubt, or when symptoms persist, seek medical attention. Never give anything by mouth to an unconscious person. Lifeguards should pay attention to self-protection and use the recommended protective equipment if there is a possibility of exposure. 4.2 MOST IMPORTANT SYMPTOMS AND EFFECTS, BOTH ACUTE AND DELAYED:

4.3 INDICATION OF ANY IMMEDIATE MEDICAL ATTENTION AND SPECIAL TREATMENT NEEDED:

Notes to physician:

The product inhaled during vomiting could cause lung damage. Thus, emesis should not be induced, neither mechanically nor pharmacologically. In the case of ingestion, empty the stomach with caution.

Antidotes and contraindications:

Specific antidote not known. In the case of a pneumonia by chemical agents, must be considered a therapy with antibiotics and corticosteroids.

SECTION 5: FIREFIGHTING MEASURES

5.1 EXTINGUISHING MEDIA:

Extinguishing powder or CO₂. In the case of more important fires, also alcohol resistant foam and water spray/mist. Do not use for extinguishing: direct water jet. Direct water jet may not be effective to extinguish the fire, since the fire may spread.

5.2 SPECIAL HAZARDS ARISING FROM THE SUBSTANCE OR MIXTURE:

As consequence of combustion or thermal decomposition, hazardous products may be produced: carbon monoxide, Carbon dioxide. Exposure to combustion or decomposition products may be a hazard to health.

5.3 ADVICE FOR FIREFIGHTERS:

Special protective equipment:

Depending on magnitude of fire, heat-proof protective clothing may be required, appropriate independent breathing apparatus, gloves, protective glasses or face masks and boots. If the fire-proof protective equipment is not available or is not being used, combat fire from a sheltered position or from a safe distance. The standard EN469 provides a basic level of protection for chemical incidents.

SECTION 6: ACCIDENTAL RELEASE MEASURES

- BIOLOGICAL LIMIT VALUES:

Biological monitoring can be a very useful complementary technique to air monitoring when air sampling techniques alone may not give a reliable indication of exposure. Measurements reflect absorption of a substance by all routes.
