- BIOLOGICAL LIMIT VALUES:

Biological monitoring can be a very useful complementary technique to air monitoring when air sampling techniques alone may not give a reliable indication of exposure. Measurements reflect absorption of a substance by all routes. Provide adequate ventilation. Where reasonably practicable, this should be achieved by the use of local exhaust ventilation and good general extraction.
