SECTION 4: FIRST AID MEASURES

DESCRIPTION OF FIRST AID MEASURES:

SECTION 6: ACCIDENTAL RELEASE MEASURES

- 6.1 **PERSONAL PRECAUTIONS, PROTECTIVE EQUIPMENT AND EMERGENCY PROCEDURES:**
